Report on Sakhalin Public Meetings held by Sakhalin Energy in 2010

In 2010, the Company held meetings with the public in order to fulfil its commitments specified in the "Information Campaign and Public Consultations Plan" and inform the public about implementation of the Project. Meetings were held in settlements directly affected by the Project. In total representatives of Sakhalin Energy visited 18 settlements in 9 districts of Sakhalin Oblast during the campaign. The total number of people who attended the meetings is over 200 people.

How long is it planned to produce Sakhalin oil and gas?	As regards Sakhalin-2 project fields – 35-40 years. With the advent of new technologies in oil and gas production the timing may change. Besides the Sakhalin-1 and Sakhalin-2 projects there are 8 more offshore projects on the island, the development of which will be implemented upon decision of the Government of the Russian Federation
Will a flare be installed at Val gas transfer terminal, which is presently under construction?	There is no need to install a flaring unit at this asset
Will the Company install a road barrier at the access road at the place of construction of the gas transfer terminal in Boatasino?	The gas transfer terminal is a hazardous facility. There are certain standards according to which the protection zone around the construction site of the gas transfer terminal will be 25 meters. There is no provision for the construction of the road barrier at the access road constructed in the area of Boatasino.
Which consequences may follow if vandals try to attack the gas intake station or a block valve and open gas?	The site, where the gas transfer terminal is going to be built, will be secured. For security purposes, there will be installed all the necessary protection equipment and security cameras, which will be controlled in real-time by an operator. And in case of an emergency situation, the operator would immediately and adequately respond to the problem.
Why temporary construction camps, which are no longer used, cannot be handed over to local residents?	According to the production sharing agreement there were paid no customs duties with respect to part of the camps imported into the country and now we can transfer them only to the state.
When will the upgrade of Korsakov-Novikovo road complete?	Korsakov administration is the customer of the road upgrade; therefore these questions should be addressed to the customer. Sakhalin Energy is only the project investor.
Korsakov beach was taken away and nothing has been done: there is no park, no swimming pool. How was the money used?	800 thousand US dollars was allocated for the reconstruction of the park based on the results of studying the public opinion. The Company raised the amount to 930 thousand and the following works were performed: construction of stairs, access roads, asphalting of internal paths, installation of electric poles, installation of electricity, benches, garbage cans. The Company was the investor, while Korsakov urban district administration was the customer.
